The Ministry of Taxation has established an Implementation Center for Customs (ICT). The primary task of ICT is to initiate to comply with the EU 'Union Customs Code' ('UCC'), thus t conduct the modernisation and digitisation of the customs area. Among other purposes this process has been.

In this connection ICT intends to conduct a market dialogue on general and strategic topics related to the modernisation and digitisation of the customs area.
